**Food Vendors are to contact City of Kingsville Health Department at 361-592-3324 to obtain a permit and receive guidelines for selling food in Kleberg County.**

No gas, propane, butane cookers are allowed inside the JK Northway. All cooking must be done with electricity or on pits outside and must follow Health Dept guidelines. Food Handlers permits are also required for all serving of food.

General Release & Hold Harmless Agreement
